JUDGING PROGRAM

Judges are not required to wait for dogs. They will adhere as closely as possible to the Judging Schedule printed in this program. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. Neither the club nor the Show Secretary have any obligation or responsibility to provide a service, through a public-address system, or stewards, or runners, for the purpose of calling or locating dogs that are not brought into the ring when required.

TRANSFER OF ENTRIES

Dogs which, according to their owner's records, have completed the requirements for a championship after the closing of entries for this show may be transferred from the regular Dog or Bitch class to the Best of Breed class, provided this transfer request is made in writing to the Show Secretary at least 30 minutes prior to the start of that show's regular conformation judging.

COVID-19 NOTICE

All persons entering the show site fully attest to the best of their knowledge that they do not have COVID-19 at the time of attending the events. They will also follow all CDC, Federal, State of Illinois, and McHenry County guidelines regarding COVID-19. Entrants must wear facemasks at all times in and around the show ring. 6-foot social distancing must be maintained everywhere on the show grounds.

All persons entering fully submit that the AKC, ITCC, site control and all other staff and their employees and all workers or volunteers, are in no way liable for any present or future COVID-19 exposure incurred at any time by any person, in attendance or not in attendance, during or after this event, and hereby waive all rights to file a lawsuit against above if they are exposed to COVID-19.

LIABILITY: It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made.

The Irish Terrier Club of Chicago, Stirling Irish Terrier Kennel, The Irish Terrier Club of America, any club members, and any other personal associated with the shows will assume no responsibility for any loss, damage, illness or injury sustained by exhibitors or handlers, or to any of their dogs or property.

This club does not agree to arbitration as listed on the entry form.

SITE INFORMATION

- The show site is open Saturday from 9 am to 4 pm. Parking is free.
- Exhibitors should bring their own EZ-ups as there will NOT be a grooming tent. Crates, tables & ex-pens are permitted. No overnight crating due to COVID-19. Please plan ahead.
- Public dog ex-pen area will be available. PLEASE clean up after your dog!
- Exhibitors will need to bring their own chairs.
- Grooming in the parking area is allowed, but no EZ-ups or ex-pens due to limited space.
- No power will be available, no generators or blow dryers are allowed due risk of spreading COVID-19.
- No washing of dogs on show grounds.
- No EXTENDED Flexi-leads allowed on show grounds.
- Due to COVID-19 these shows are CLOSED to the General Public. NO spectators are allowed.
- No RVs or trucks.
- Complimentary beverages and lunch items will be provided between shows.

DIRECTIONS

Taking I-47 into Woodstock, turn east onto Country Club Rd. Continue for about 2 miles. While on Country Club Rd., you will pass the McHenry County Fairgrounds and the entrance to the Bull Valley Golf Club. You will then pass a sign that says that you are entering the Village of Bull Valley, and you will see the Woodstock golf course on your left. You will see a yellow intersection sign for Deer Path.

Turn right onto Deerpath Rd. and continue for 0.3 of a mile.
The entrance will be on the left (the driveway before the mailbox with "10439").
