- Breeder must be willing to be a mentor and advisor for anyone who buys a puppy
- from them. They must also be willing to take a puppy back at any age.

 Breeder will provide a written contract, along with AKC registration papers or other
- AKC-approved registry with each puppy sold. It is recommended that all puppies sold as pets be place on a "Limited Registration."
 - As an ethical breeder, all known genetic problems in the lines sold to new home will be disclosed.
- Breeder will not engage in whole selling of litters or individuals to any pet store or commercial establishment. No puppies shall be donated to raffles or auction or given
